**TUITION AGREEMENT**

Each accepted student into the Ascend Academy is required to sign and return a Tuition Agreement form to the Academy. This form states that the student agrees to their responsibility of their tuition before classes begin and that they will comply with leadership throughout the course of the two-year program. Tuition payments are non-refundable.

Should any student not comply with leadership, Ascend Academy has the right to dismiss said student at any given time with any tuition monies paid non-refundable.

All charges for the current trimester are due in full by the first date of class each trimester. Tuition installment options are available by trimester, year, or paid in full two-year program (one installment). Balances not paid by the due date are considered past due and students will not be allowed into the course. Any holds on student accounts will prevent students from registering for classes, viewing grades, and receiving a completion certificate upon graduation.
